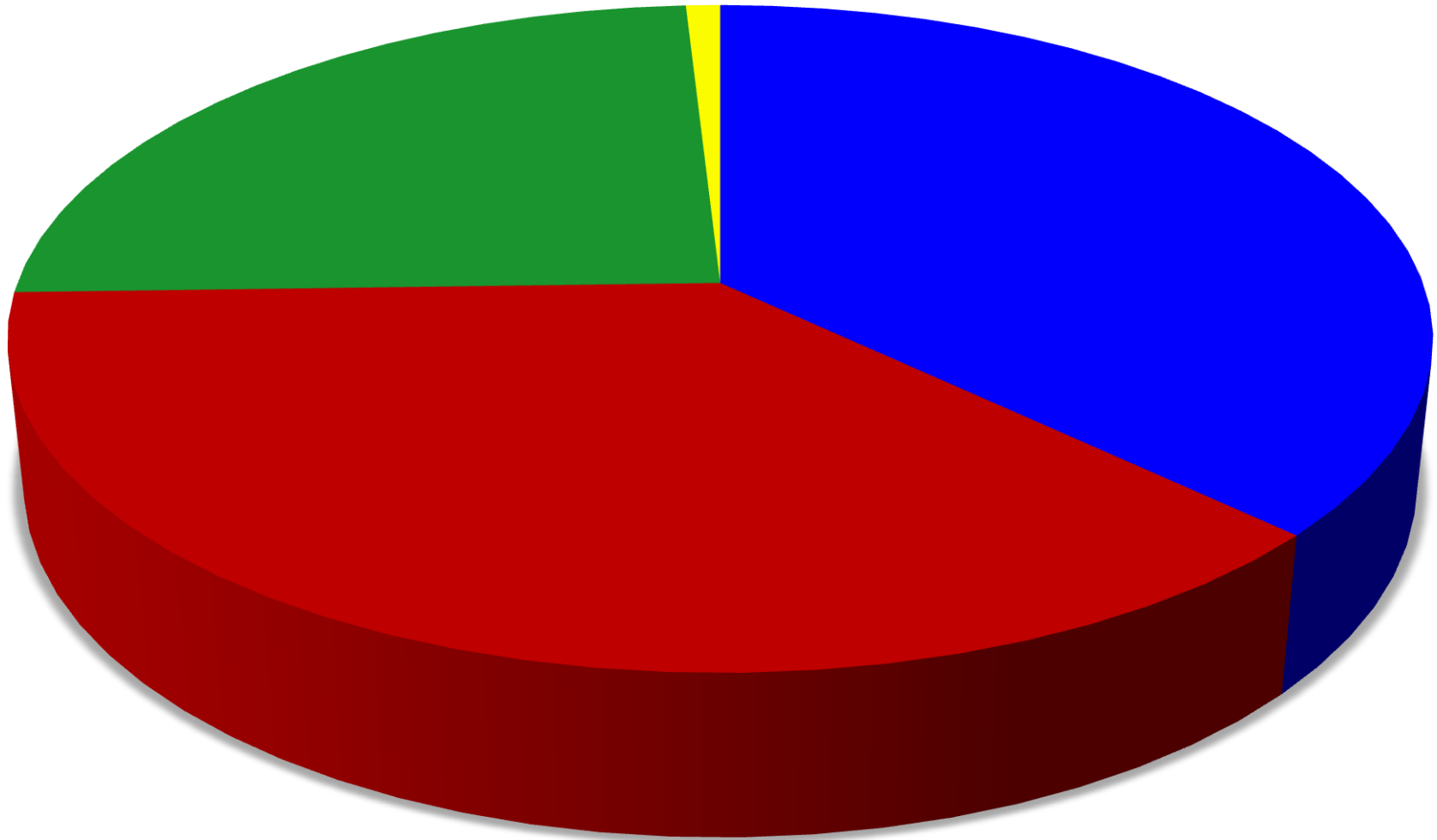

Active Grants By Category



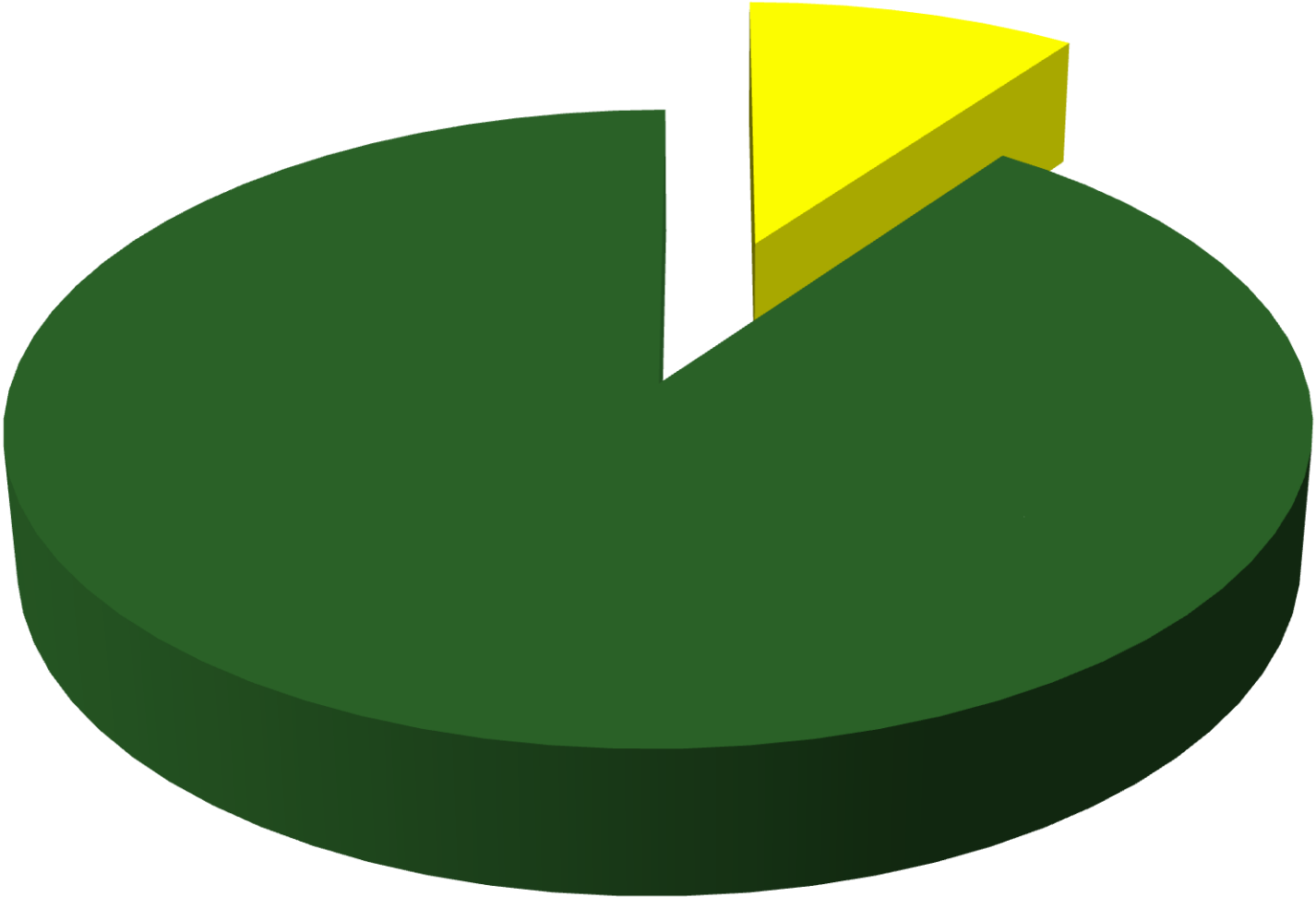
