DIRECTOR OF THE LUMPKIN COUNTY EMERGENCY MANAGEMENT AGENCY**



Resolved, adopted and effective this 16th day of December, 2010.

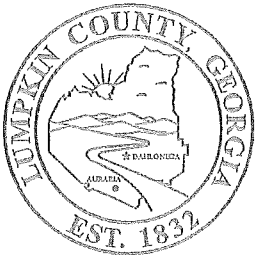
