Whereas, the governing authority of Lumpkin County has advised that it wishes to reappoint Kimberly Pruitt to Seat Five of the Board of Elections;


Now therefore, it is hereby resolved that:





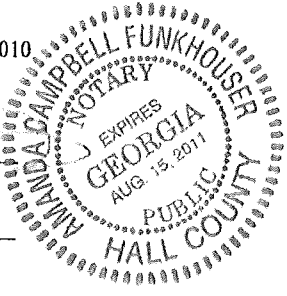
