
A RESOLUTION TO AMEND
THE
LUMPKIN COUNTY 2012 BUDGET CALENDAR

Whereas, the governing authority of Lumpkin County, on November 18, 2010, adopted the Lumpkin County, Georgia 2012 Budget Calendar setting out the dates and times for establishing the 2012 budget for the fiscal year beginning January 1, 2012; and,

Whereas, the 2011 property tax assessments were originally scheduled to be mailed on April 15, 2011; however, due to changes in the state laws, the 2011 property tax assessments were not issued until June 13, 2011, changing the last day to appeal tax assessments from June 1, 2011, until July 28, 2011, necessitating a need to amend the 2012 Budget Calendar;


Now therefore, it is hereby resolved that the date for appeal of tax assessments for the payment of ad valorem taxes in 2011 (for the 2012 Fiscal Year) shall be July 28, 2011, and the calendar as previously adopted shall be amended as set out on the attached Exhibit "A," which is by reference incorporated herein, and said calendar as amended shall be the official Lumpkin County, Georgia 2012 Budget Calendar for Fiscal Year Beginning January 1, 2012.

FOR FISCAL YEAR BEGINNING 1/1/2012
(Calendar Date - Start 03/14/2011)**

- March 14, 2011** - **BUDGET PREPARATION**
Provide budget request forms and budget preparation calendar to elected officials and department heads.
- April 1, 2011** - **PROPERTY TAX RETURNS**
Property tax returns must be filed with the Lumpkin County Board of Tax Assessors between January 1 & April 1 of each year. The taxpayer may elect not to file a property tax return if there have been no changes that would affect the value of their property from the previous year. O.C.G.A. § 48-5-18
- April 8, 2011** - **BUDGET REQUEST**
Completed budget request forms are due back to Finance Department.
- April 18, 2011 -
April 29, 2010** - **BUDGET COMMITTEE**
Committee will review requests and make recommendations. Finance Department will prepare proposed budget for review by elected officials and department heads.
- May 9, 2011 -
May 20, 2011** - **CONFERENCES - BUDGET COMMITTEE**
Analyze proposed budget and hold public conferences with elected officials and department heads. 1-hour sessions per department to discuss changes.
- June 7, 2011** - **PRESENT PROPOSED BUDGET**
Present proposed budget at Board of Commissioners Work Session. (Finance Dept.)
- 13-Jun-11** - **MAIL ASSESSMENT NOTICES (Begin 45 day appeal period)**
Change in assessment notices mailed by Tax Assessors. O.C.G.A. § 48-5-306
- June 13, 2011 -
June 17, 2011** - **BOARD OF COMMISSIONERS & BUDGET COMMITTEE MEETINGS**
Board of Commissioners and Budget Committee meetings to set final budget.
- June 29, 2011** - **PUBLISH MILLAGE RATE & 5 YEAR HISTORY**
[Advertise millage rate & 5 year history: June 29](#)
Publish at least two (2) weeks prior to establishment of millage rates. O.C.G.A. § 48-5-32
- June 29, 2011** - **ADVERTISE PUBLIC HEARING AND AVAILABILITY OF BUDGET**
[Advertise public hearing: June 29 & July 6](#)
Notice shall be published at least seven (7) days before the budget hearing is held. O.C.G.A. § 36-81-5
- June 29, 2011** - **ADVERTISE PUBLIC HEARING "NOTICE OF PROPERTY TAX INCREASE"**
[Advertise public hearing: June 29 & July 6](#)
If proposed millage rate increases beyond roll-back rate the levying authority shall advertise its intent to do so and shall conduct at least three public hearings thereon, at least one of which shall commence between the hours of 6:00 p.m. and 7:00 p.m. O.C.G.A. § 48-5-32.1

- July 6, 2011** - **ADVERTISE ADOPTION OF TENTATIVE BUDGET**
Advertise meeting: July 6 & July 13
Budget must be adopted at a public meeting, which shall be advertised at least one (1) week prior to the meeting. O.C.G.A. § 36-81-6
- July 12, 2011** - **PUBLIC HEARING ON PROPOSED BUDGET**
Meeting at 6:00 p.m. - Lumpkin County Administration Building O.C.G.A. § 36-81-5
- July 12, 2011** - **PUBLIC HEARING "NOTICE OF PROPERTY TAX INCREASE"**
Hearing held if proposed millage rate increases beyond roll-back rate.
Meeting at 7:00 p.m. - Lumpkin County Administration Building
- July 14, 2011** - **PUBLIC HEARING "NOTICE OF PROPERTY TAX INCREASE"**
Hearing held if proposed millage rate increases beyond roll-back rate.
Meeting at 9:00 a.m. - Lumpkin County Administration Building
- July 21, 2011** - **PUBLIC HEARING "NOTICE OF PROPERTY TAX INCREASE"**

Last date to appeal assessment change to Tax Assessors.
- September 15, 2011** - **TAX BILLS MAILED (Upon State approval of County Tax Digest)** O.C.G.A. § 48-5-220
- November 15, 2011** - **TAXES DUE (60 days after bills are mailed)** O.C.G.A. § 48-5-233
- January 1, 2012** - **FY 2012 BEGINS**
