


**LUMPKIN COUNTY RESOLUTION NO. 2012-02**

Qualifying for **partisan and non-partisan** offices will begin Wednesday May 23, 2012, at 9:00 am and will end on Friday, May 25, 2012, at noon.

\*O.C.G.A. § 21-2-131 requires fees to be set as follows:

- 1) Clerk of Court, Probate, Sheriff, Tax Commissioner, Magistrate = 3% of Minimum Salary
- 2) County Commissioners = 3% of Base Salary
- 3) All other other salaried positions = 3% of prior year's gross salary including all supplements
- 4) All other non-salaried positions = 3% of income derived from office in prior year

***Please note the law has changed and all qualifying will be held at the same time this year. Also, due to this election cycle following a decennial census, the qualifying dates are shortened by state law, from five days to three.***
