CALL TO ORDER

Vice-Chairman Stowers began the meeting at 6:02 p.m. in the Boardroom of the Lumpkin County Administration Building. Present were Doug Sherrill, Steve Shaw, Clarence Stowers, and Clarence Grindle. Chris Dockery was absent from the meeting.

INVOCATION

Bethlehem Baptist Church Pastor Michael Rodgers gave the invocation, which was followed by the pledge of allegiance led by the Lumpkin County Park & Rec 8U Football Team.

APPROVAL OF AGENDA

Motion: Commissioner Sherrill made a motion to amend and approve the amended agenda, placing the Proclamation before Presentations. That motion was seconded by Steve Shaw and approved by Doug Sherrill, Steve Shaw and Clarence Grindle. Motion carried.
