Dear Allison,

Thank you for the opportunity to continue to serve the Lumpkin County Detention Center. As you may know, our Health Services Agreement is due for renewal on January 1, 2015. To that end, I am enclosing an Amendment, which will renew our contract from **January 1, 2015 through December 31, 2015**.

Further, as you know, our Health Services Agreement allows for a CPI-W increase with each annual renewal. Currently, the applicable CPI-W is 1.5%. However, we have agreed to **WAIVE** the CPI-W increase for this renewal period, in exchange for the waiver of the performance bond requirement, as set forth by the 2011 RFP. As such, our fees will remain, as follows:
