**Whereas**, the Lumpkin County Board of Commissioners recognizes the Dahlonega Sunrise Rotary Club award of the Employee of the Year for a deserving employee of the Lumpkin County general operations, Lumpkin County emergency services and the Lumpkin County sheriff's office; and,


**Whereas**, the County governing authority desires to join with the recognition, to include a monetary award of \$250.00 for each person receiving such award; and,

**Whereas**, it is further desired that the Department of Community and Employee Services provide administratively for the payment of such award, subject to taxes, with such provisions being made a part of the Lumpkin County Employee Handbook and Civil Service Plan;

**Now, therefore, be it resolved** that at the time the Dahlonega Sunshine Rotary Club designates its recipients for the above set out award, the Lumpkin County Director of Community and Employee Services shall so advise the Lumpkin County Manager, and the designees shall be presented to the Board of Commissioners at the next regular meeting and the Lumpkin County award shall be delivered by the Chairman and the District Commissioners present;

**To Be Incorporated into the Lumpkin County Employee Handbook  
and Civil Service Plan**

Section \_\_\_: Financial Award for Lumpkin County Employees of the Year

Each year, Lumpkin County selects three Employees of the Year, one for General Operations, one for Emergency Services, and one for the Sheriff's Office. In addition to the recognition attached to this title, the County will award each of the three employees \$250.00. This will be in the form of a separate check and will be subject to regular taxes.

Upon selection and announcement of each of the three Employees of the Year, the County Manager will direct, in writing, that checks be prepared for each of the three employees. Additionally, a copy of the County Manager's instructions will be forwarded to the Finance Department. After the checks have been prepared, they will be delivered to the County Manager for distribution.
