Law Enforcement – Safety Equipment

Item Description: The US Department of Justice has approved a grant award in the amount of \$7,350.00 to the County for the purchase of bulletproof vests for its law enforcement officers.

Facts & Historical Information:

Earlier this year, the County prepared and submitted a grant application for funding assistance from the US Department of Justice through its Bulletproof Vest Partnership (BVP) initiative. Grants of this nature, when combined with local funds have enabled the County to acquire much needed safety equipment for its law enforcement officers while minimizing the impact to the County's operating budget.

After consulting with representatives of the Sheriff's Office, the FY-2016 application was developed and funding assistance was requested from the BVP. The County's application was approved and \$7,350.00 has been awarded.

Potential Courses of Action:

- A. Accept the FY-2016 BVP award in the amount of \$7,350.00.
- B. Take no action.

Budget Impact:

There will be no negative impact to the County's operating budget. The matching requirement will be met by utilizing existing funds budgeted for equipment purchases.
